

Terms & Conditions - Eleven Eighteen Charity

Release & Waiver of Liability

IN CONSIDERATION of being permitted to participate and contribute in any way to the mission and activities of Eleven Eighteen Charity, for myself and for any of my personal representatives, heirs, assigns, or next of kin, do hereby understand and agree to the following:

1118 Charity and Volunteer Opportunities. I understand and acknowledge that 1118 Charity is a non-governmental, non-political, non-profit international relief and development organization. 1118 Charity's projects provide opportunities for volunteers to engage in hands-on service activities to advance social change both in the United States and abroad.

Voluntary Service. I understand and agree that my relationship with 1118 Charity is limited to a volunteer position, and that no compensation is earned or expected in return for the services I render on behalf of 1118 Charity. I also understand that 1118 Charity will not provide any benefits traditionally associated with employment and that I am solely responsible for insurance to cover any illnesses or personal injury that may arise during my volunteer service with 1118 Charity.

Assumption of Risk. I acknowledge that this document is a release and waiver of liability for the benefit of 1118 Charity, its affiliates, officers, directors, employees, volunteers, and representatives. I am knowingly and willingly assuming any potential risks and dangers to my personal safety and security. I understand that my services may involve inherently risky activities, including, but not limited to, driving, traveling, lifting loads greater than five pounds, or any other physically demanding activities. I expressly assume the risk of injury or harm inherent in these activities, whether caused by my own actions or those of 1118 Charity or others.

Conduct. As a volunteer, I agree to act in accordance with 1118 Charity's Code of Ethics.

Financial Responsibility and Insurance. I understand that 1118 Charity does not assume responsibility for providing financial assistance or insurance for any personal injury, death, or property damage. I accept all responsibility for losses, costs, and damages, including legal fees, medical, health, and disability benefits, and I waive any claim for compensation from 1118 Charity beyond what may be offered freely in the event of injury or medical expenses incurred by me.

Release of Liability. I RELEASE, DISCHARGE, AND HOLD HARMLESS 1118 Charity, its affiliates, officers, directors, employees, agents, volunteers, and representatives (hereinafter collectively the "Released Parties") from any and all liability, claims, demands, losses, damages, actions, or causes of action (including personal injury, property damage, and wrongful death), whether known or

unknown, anticipated or unanticipated, arising out of or related to my volunteer service or participation in 1118 Charity's activities.

Indemnification. I agree to indemnify, save, and hold harmless 1118 Charity and all of its affiliates, officers, directors, employees, agents, volunteers, and representatives from any litigation expenses, ELEVEN EIGHTEEN CHARITY - Youth-Focused Charity Est. 2023 ELEVEN EIGHTEEN CHARITY Youth-Focused Charity attorney fees, loss, liability, damage, or other costs resulting from any claims arising from my actions or omissions.

I agree not to use 1118 Charity's name or resources in connection with any political or commercial activities unless specifically authorized by 1118 Charity.

Complete Release. This release and waiver constitute a complete, perpetual, and unconditional release of any and all claims to the fullest extent allowed by law. Severability.
